## ***Report on Singapore Conference, June 2006, "Chinese Nation – Chinese State, 1850-2000"***

The conference attracted a wide range of participants, including representatives of the USA, Canada, UK, France, Portugal, China, Japan, Korea, Singapore, Hong Kong, Taiwan, Australia and New Zealand. Sixty-five papers were presented in 17 panels. Topics generally covered the various conceptions of China that have existed since the late Qing, and how these have engaged the changing political realities. Most papers came from the discipline of history, but topics ranged from politics to opera. Professor Wang Gungwu opened the conference with a compelling address on the conference theme. The conference was sponsored by the Faculty of Arts and Sciences, East Asian Research Institute and Asia Research Institute of the National University of Singapore, and it was organized by Thomas Dubois of NUS. ## ***Minutes of Business Meeting, April 8, 2006, San Francisco Marriott***

Present: President Elisabeth Koll, Vice-president Keith Schoppa, and about ten members.

Presiding: President Elisabeth Koll, who called the meeting to order at 1:00 pm.

1. Approval of Minutes. The minutes of the previous business meeting on April 2, 2005 were approved on a motion.

2. President's Report. President Koll thanked Vice-president Keith Schoppa for presiding over the previous year's meeting when she was in China. The president gave a brief update on the HSTCC website. Work is being done on the site. She also reported that discussion of a joint agreement between the HSTCC and *Twentieth Century China* had been delayed because of the transfer of the journal from Michigan University Press to Ohio State University Press. The proposal remains active, however, and Keith Schoppa (incoming HSTCC president and chair of the board of TCC) will discuss the matter further with TCC editor Christopher Reed.

3. Financial Report. President Koll presented the financial report from Secretary-Treasurer David Barrett, who could not attend. The current balance is \$7,521. The society has 65 currently paid-up members, of whom 12 are lifetime members.

4. Election of Incoming Officers. Vice-president Keith Schoppa assumes the position of president for the next two years. For the five Board positions, President Koll presented the names of four nominations she had received: Morris Linan Bian (Auburn University), James (Jay) Carter (St Joseph's University in Philadelphia), Thomas Dubois (National University of Singapore), and John Fitzgerald (LaTrobe University, Australia). Nomination of Elisabeth Koll of Case Western University was made from the floor. The slate of five was unanimously approved, with James Carter chosen as Vice-president.

President Koll presented the nomination of Ke-wen Wang of St. Michael's College, Vermont, as the new secretary-treasurer. The nomination was approved unanimously.

5. Singapore Conference. Thomas Dubois of National University of Singapore reported on the upcoming conference to be held at the university. There are currently 72 papers accepted. Scholars from the PRC will be fully funded under a grant from the university.

6. The business meeting was adjourned at 1:25 pm. The meeting was followed by a round table discussion of *Mao: The Unknown Story*, by Jung Chang and Jon Halliday, with approximately 100 people in attendance.
