## The HSTCC Biennial Conference at the East -West Center, Honolulu, Hawaii, June 16-17, 2008

The theme for our forthcoming conference is "Chinese Identities: Local, Regional, National, Global." There are 50 papers being presented, 6 papers by scholars from the People's Republic of China, 32 from the United States, 3 from Canada, 2 from Singapore, and 1 each from Germany, Japan, Australia, New Zealand, Hong Kong, Taiwan, and Korea.
